Our articles made of the above mentioned material particularly meet following limits:

- □ general level of migration does not exceed 10mg/dm²
- □ sum of concentration levels of lead, cadmium, mercury and hexavalent chromium does not exceed 100mg/kg

The main purpose of our articles is the consumption of all kinds of food, including fatty, sour and alcoholic food.

It is important to pay attention to the fact that range of temperature during practical use of our articles should meet the scope between -20° C and $+80^{\circ}$ C. However, because of special purpose of use of brown-white drinking cups, which is use in coffee vending machines, level of temperature endurance of brown-white cups is increased up to $+80^{\circ}$ C.

Particularly, it should be stressed, that limit of high temperature endurance must not be exceeded.

It is also very important to notice, that the above mentioned articles CANNOT be applied for food heating in microwave ovens.

Provided that the above mentioned safety temperature indications are obeyed, our articles placed on the market and used under normal or foreseeable conditions of use, cannot:

- endanger human health;
- bring about an unacceptable change in the composition of the food;
- □ bring about a deterioration in the organoleptic characteristics of food.

Our articles are manufactured in compliance with Good Manufacturing Practice (GMP) according to Commission Regulation (EC) No 2023/2006 (Official Journal of the European Union no L384 of 29.12.2006) and Good Manufacturing Hygiene (GHP)

Additionally, Kreis Pack Sp. z o. o limits the quantity and negative environmental impact of substances used for manufacturing of packaging and waste packaging produced, in particular::

- □ It limits volume and weight of packaging to an absolute minimum so that it performs its function taking into account user's expectations,
- □ It designs and makes products in a way allowing for their recycling.
